Technology Liability Agreement

In an effort to ensure that all students have the resources needed to achieve the educational objectives outlined by Legacy Prep Charter School, scholars will have the opportunity to check out an assigned school-owned device for educational enrichment at home. This agreement applies to all technology resources used in accordance with the Student Technology Use Agreement. As a scholar, you are fully responsible for the school-owned device during your check-out period. Prior to checking out any school-owned device, you must complete the Technology Liability Agreement and be approved by the school's Technology Coordinator before leaving the school's premises. Both scholar and parent(s) must agree to the following statements regarding the use of school-owned devices during the duration of the check-out period, but understand that this list may not be exhaustive.

Statement of Expectations

- I will not leave the device unattended to prevent theft or damage.
- I will not attempt to repair or replace the device if damaged but will report any loss or damage to the device immediately to the school's Technology Coordinator.
- I will not loan out my school-owned device to anyone.
- I will not attempt to resell (i.e., "pawn") school-owned property for personal profit or gain.
- I will not try to circumvent any security measures or filters.
- I will not alter (i.e., "jailbreak") system configurations by installing or deleting applications and/or software.
- I will not vandalize my device by adding stickers or any markings directly onto it.
- I will not attempt to access inappropriate materials online.
- I will not send or post inappropriate or threatening messages/material.
- I will ensure the safety of the device assigned to me and prevent negligent damage to the device.
- I will use my school-owned device only for the purposes of non-commercial use in accordance with the Student Technology Use Agreement, as well as local, state, and federal law.
- I will return my school-owned device and all its assigned accessories in the same working condition in which it was loaned, in accordance with the procedures outlined by the school.
